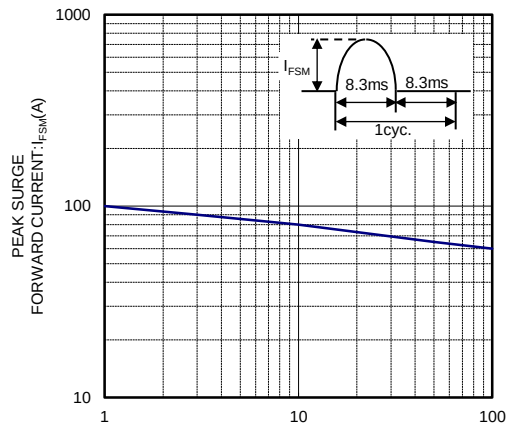




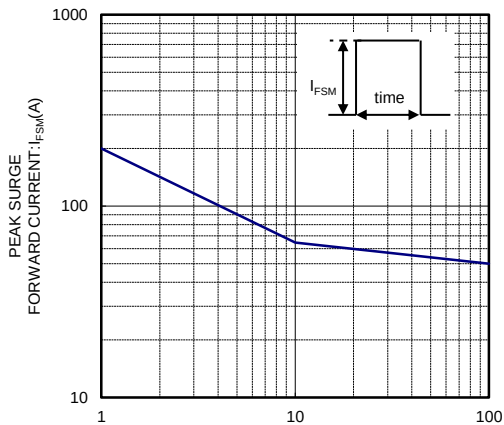
I_FSM DISPERSION MAP



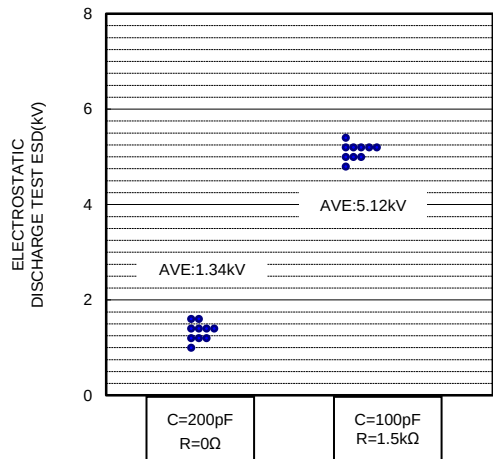
t_rr DISPERSION MAP



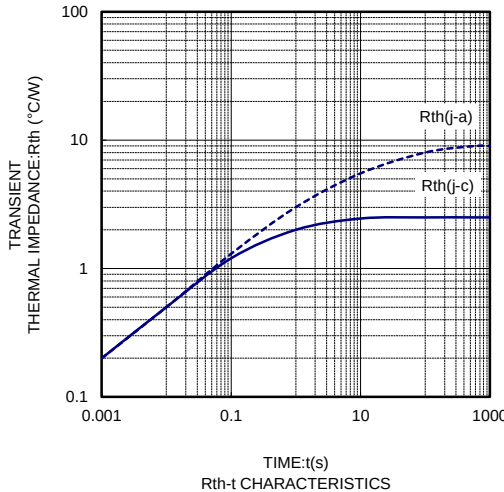
I_FSM CYCLE CHARACTERISTICS



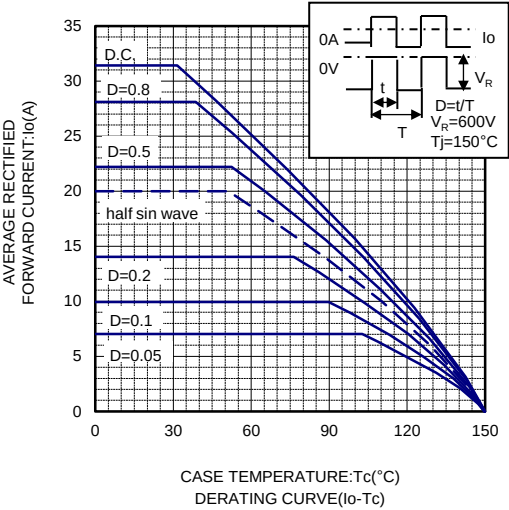
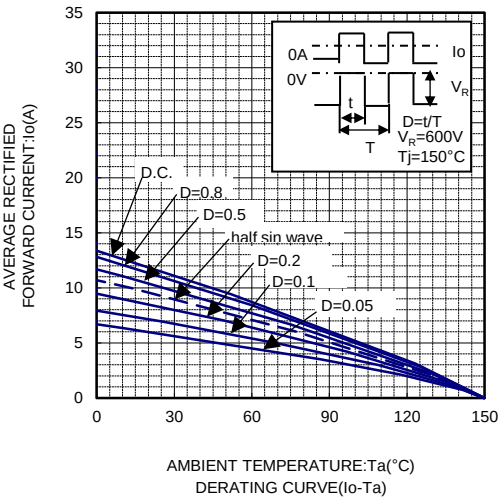
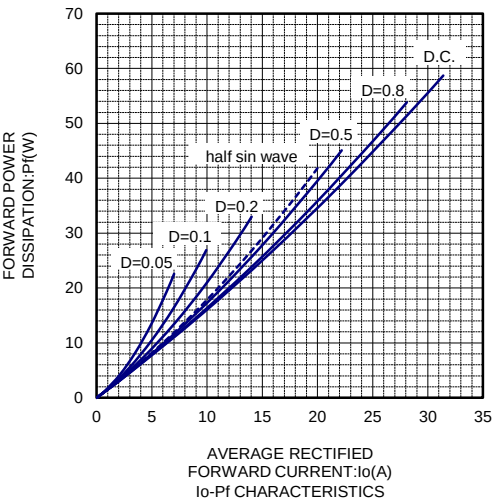
I_FSM-t CHARACTERISTICS
